5.1 East Suffolk Council - Suffolk Coastal Local Plan Consultation on Main Modification - council had no comment to make on the Consultation

5.3 New NALC member Code of Conduct - consultation, The Chair will complete the online form.

A Study showed the route from Border Cot lane to Rackhams Mill to be viable, WM traffic figures however show a higher volume of traffic than figures given by EDF. EDF to meet HPC and neighbouring parishes to discuss concerns over Park and Ride site.
